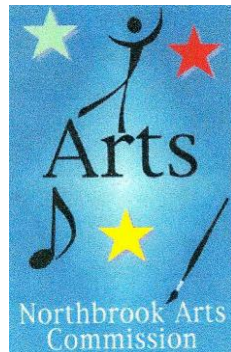

You are applying for space at the Young Artist Show at the Art in the Park Festival —Northbrook on July 10 and July 11. Show hours are 10 am - 5 pm on Saturday, 11- 5 on Sunday. **Young Artists between the ages of 8 and 17 may apply.**

**THE DEADLINE FOR APPLICATION IS JUNE 15, 2010.
SPACE IS LIMITED TO A MAXIMUM OF 12 ARTISTS PER DAY.**

1. Artists must provide their own display items including table, chairs etc.
2. Artists are responsible for control of all cash in their possession.
3. Artists must sign up for at least 1 full day and can sign up for 2. Set-up begins at 9am. Shut-down begins at 5pm. *Early shut-downs are not allowed.*
5. Artists ages 8 thru 12 must have full time adult supervision for the entire day.
6. Pets are not allowed at the Festival.
7. Set up information and table location will be forwarded to you June 30, 2010.
